INTRODUCTION

In healthcare, immunization tracking plays a vital role in ensuring employees and clinical students are protected from contracting illnesses from the patients they care for and observe. Healthcare workers are inherently at risk for exposure to, and possible transmission of, vaccine-preventable diseases.

Immunization tracking allows for healthcare organizations and educational institutions to manage the vaccination and health record requirements of their employees and students, those who have not been vaccinated yet, and those who are due for updated vaccines. Immunization tracking programs have many benefits,¹ including:

- Increased compliance with the Health Insurance Portability and Accountability Act (HIPAA) and the Family Educational Rights and Privacy Act (FERPA), as well as state health requirements;
- Increased efficiency from less paperwork;
- Increased safety for employees, students, patients, and staff in healthcare settings;
- Interpretation of a complex immunization schedule; and
- Allowing the introduction of new vaccines or changes in vaccination schedules accordingly.

We've learned from COVID-19 the value of having an immunization tracking program in place that can endure rapidly-evolving conditions, especially in an industry like healthcare.

IMMUNIZATION TRACKING REQUIREMENTS

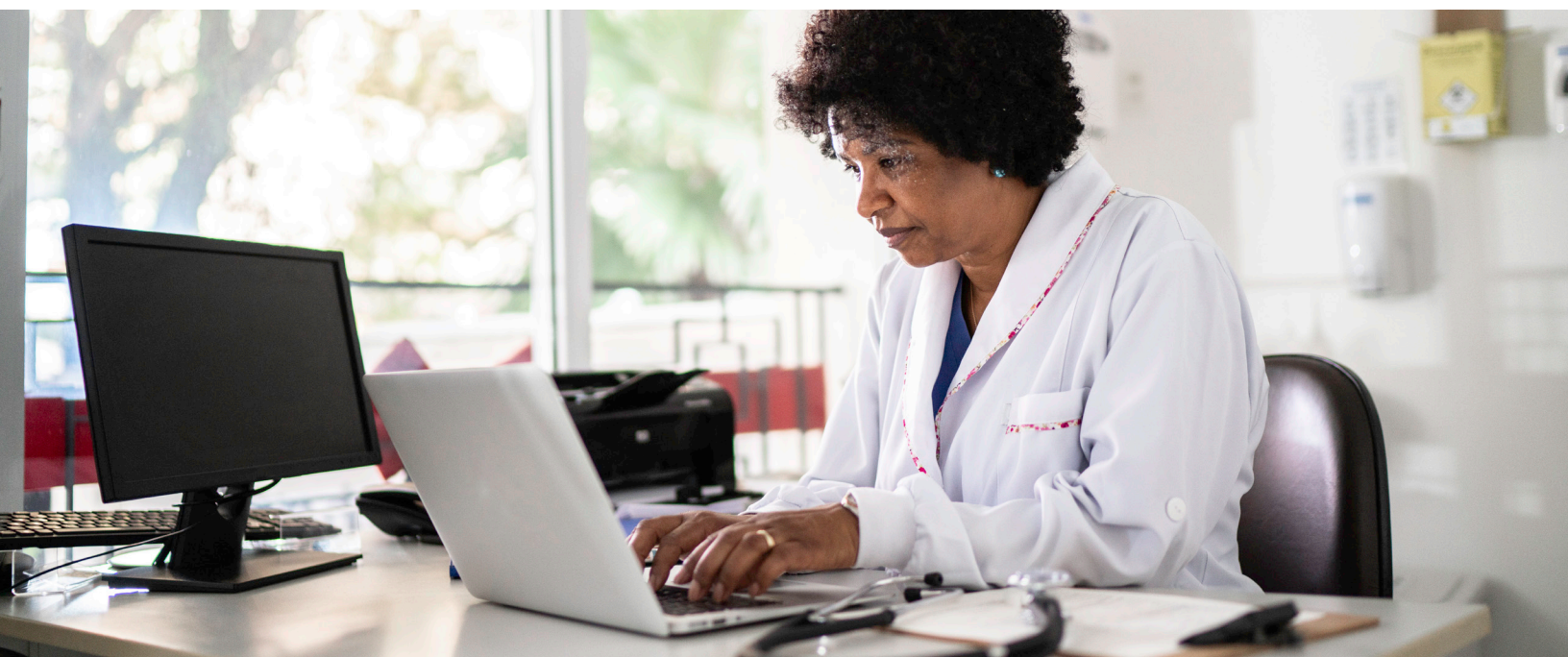
Immunization requirements vary by healthcare organizations for students and clinical rotations. Depending on the program, some of the following may be required:

- COVID-19, including boosters
- Hepatitis B
- Annual influenza vaccine
- Measles, mumps, and rubella (MMR)
- Tetanus/DTaP
- Pneumococcal disease
- Varicella (chickenpox)
- Polio

Healthcare organizations should utilize an immunization tracking program that requires documentation of required vaccines, rather than a self-reporting system. This ensures that all data is authentic and validated by healthcare and medical record professionals, which increases safety and reduces liability.

KEY CHALLENGES

Perhaps the largest challenge when managing an immunization tracking program is ensuring it is compliant with all state and local guidelines.² Laws vary from state to state, and can even vary by type of facility. A good immunization tracking software will ensure healthcare organizations and



schools are compliant with each of these requirements. Another challenge for managing immunization tracking programs is the use of adequate technology.² Healthcare organizations and schools should strive to transition away from paper documentation systems, opting for a paperless repository that allows for uploading, validation, and compliance reporting. Electronic immunization tracking can increase vaccination rates,³ increase the accuracy of vaccine documentation,⁴ and reduce the time it takes to document vaccinations.⁴ Selecting a solution that is secure and smart-phone friendly can also reduce document submission wait times and minimize exposure risk.

TOP FIVE FEATURES TO CONSIDER

Here are some key features to look for when selecting the right immunization tracking software for your organization:

1. **Software:** Select an immunization tracking program solution that meets your organization's unique immunization requirement needs, offers the flexibility of easy-to-make software changes, and is fully customizable (e.g., adding a COVID-19 booster requirement, or a seasonal influenza shot).
